

ARTICLES OF INCORPORATION

OF

USWAG Mutual Benefit Association, Inc (USWAG MBA)
(Name of Corporation)

KNOW ALL MEN BY THESE PRESENTS:

The undersigned incorporators, all of legal age and majority of whom are residents of the Philippines, have this day voluntary agreed to form a non-stock and non-profit **Mutual Benefit Association (MBA)** under the laws of the Republic of the Philippines.

AND WE HEREBY CERTIFY:

FIRST: The name of the said association shall be:

USWAG Mutual Benefit Association (USWAG MBA), INC.

SECOND: That the purpose for which such association is formed is to advance the interests and promote the welfare of the poor in particular and the interest and welfare of the Philippines in general. Specifically, the association shall seek:

1. To extend financial assistance to its members, spouse, children, and parents in the form of death benefits, total & permanent disability (TPD), sickness benefits, provident savings and loan redemption assistance;
2. To ensure continued access to benefits/ resources by actively involving the members in the management of the association that will include implementation of policies and procedures geared towards sustainability and improved services.
3. To ensure compliance with administrative and regulatory issuances, rulings and directives by professionalizing the association, management, research and development, and technical services operations.
4. To adopt a prudent cash management program to invest cash in excess of current disbursement through a majority vote of its Board of Trustees.

THIRD: That the place where the principal office of the association is to be established or located is at 0382 L. Barrios Street, Kalibo Aklan

FOURTH: That the term for which the association is to exist is fifty (50) years from and after the date of issuance of the certificate of incorporation.

EIGHT: That no part of the income which the association may obtain as an incident to its operation shall be distributed as dividends to its members, trustees or officers (that no part of the Association's net income shall inure to the benefit of any private individual) subject to the provisions of the Corporation Code on dissolution. Any profit obtained by the association as a result of its operation, whenever necessary or proper shall be used for the furtherance of the purposes enumerated in Article II, subject to the provisions of Title XI of the Corporation Code of the Philippines.


NINTH: That upon dissolution and satisfaction of all liabilities, its remaining assets shall be distributed to *one or more entities formed for the purpose/purposes similar to its own*, or to the Philippine government for public purpose.


TENTH: That Vivian C. Roldan has been elected by the members as Treasurer of the association to act as such until her successor is duly elected and qualified in accordance with the by-laws, and that as such Treasurer she has been authorized to receive for and in the name and for the benefit of the association all contributions or donations paid or given by the members.


ELEVENTH: That the association manifests its willingness to change its corporate name as herein provided, or as amended thereafter, immediately upon receipt of notice or directive from the Securities and Exchange Commission that another person, firm or entity has acquired a prior right to use the said firm name or that the firm name has been declared as misleading, deceptive, confusingly similar to a registered name or contrary to public morals, good custom or public policy.

TWELFTH: That the association shall comply with the requirements for non-stock and non-profit corporations in the course of its operation.


